The Board of Adjustment, at its regular public meeting, adopted the analysis and findings listed in the attached memorandum dated August 18, 2011, and approved the Variance to be conducted as described in the project description and project drawings submitted with the application and with the following conditions:

- 1. Prior to issuance of a Certificate of Occupancy or Temporary Certificate of Occupancy for any new mobile home, a picnic table and at least one of the following playground improvements listed below are to be in place in both approved pocket parks less than 2,500 square feet in size:
 - Wooden stepping timbers or tires placed at varying heights;
 - Sand box using natural landscape timbers as boundaries;
 - Swing set;
 - Slide; or
 - A series of balance beams placed 6" above the ground at alternating angles.
- 2. It shall be the obligation of the park owner to install and maintain playground improvements in working condition.

Expiration Date: The permit will expire 18 months after the effective date, or February 23, 2013, if no

Building Permit has been issued and substantial construction progress has not been made in accordance with the plans for which the development permit was authorized. Application for permit extension must be submitted thirty days prior to the expiration

date.
