The Planning Commission, at its regular public meeting, adopted the analysis and findings listed in the attached memorandum dated August 18, 2011, and approved the apartment complex to be conducted as described in the project description and project drawings submitted with the application, and based on additional information presented at the public hearing made the following conditions:

- 1. Prior to the issuance of a Building permit, the applicant and CDD shall stake a "Do Not Disturb" line along the wetlands or front yard setback (whichever is greater) near the right-of-way of Sunset Drive and Egan Drive. This area shall be preserved and maintained as a vegetated visual screen as long as the land is held in private ownership. Piercing of this screen shall be limited to necessary utility lines, and disturbed areas shall be immediately re-planted with similar vegetation
- 2. The driveway shall be restricted to the southwest corner of the site, away from the mapped wetlands as shown on the attached site plan. This shall be shown on a future site plan or grading plan prior to the issuance of a Building permit.
- 3. If the mapped wetlands located in the new parking lot cannot be filled, the applicant shall submit a revised parking and circulation plan to the Community Development Department for further review to determine if a revised Conditional Use permit is required.

Effective Date: The permit is effective upon approval by the Commission, August 23, 2011.

Expiration Date: The permit will expire 18 months after the effective date, or February 23,

2013, if no Building Permit has been issued and substantial construction progress has not been made in accordance with the plans for which the development permit was authorized. Application for permit extension must be

submitted thirty days prior to the expiration date.
