BACKGROUND

The Willoughby District Land Use Plan was prepared in anticipation of several large projects in the area, including the State Library Archive Museum (SLAM) project, improvements to Whittier Street and extension of the Seawalk. This plan is intended be an aspirational blue print for future development of the area. Chapter 5, which is proposed to be adopted as part of the CBJ Comprehensive Plan, makes recommendations for implementation actions such as amendments to the zoning code.

The draft plan developed by a consultant team of Sheinberg and Associates, North Wind Architects, Walker Macy and Kittleson Associates, at the direction of CBJ's Division of Land Management. The plan was presented to the Planning Commission at their regular meeting on August 9, 2011. The Commission referred the plan to the Title 49 Committee for further review and a recommendation for action. Information showing the timeline of the project and comments from the Affordable Housing Commission and Juneau Commission on Sustainability are found in Attachment A. Attachment A was compiled by the Lands and Resources Manager, Heather Marlow specifically for the Title 49 Committee.

The Title 49 Committee met December 13, 2011, December 28, 2011, and January 9, 2012, to discuss the Willoughby District Land Use Plan. At the meeting of January 9, 2012, they made specific recommendations for amendments to the draft plan, primarily Chapter 5, which will be adopted as a part of the Comprehensive Plan. Their recommendations are shown in detail in Attachment B.

Furthermore, comments from Commissioner Bennett, a member of the Title 49 Committee, are included as Attachment C. These comments are broader in scope than the recommendations of the Committee, and warrant some discussion by the entire Commission. The main points of Commissioner Bennett's comments (as determined by staff) are:

- o How the area functions today;
- o Unique features currently present in the study area, that are valued by the community, are not supported by the draft Plan but instead are discarded;
- o How people (primarily the Native community) use the area today and the impacts of proposed changes to that use;
- o Thriving local businesses are to be removed from the study area;
- o Concern that concepts from Oregon are not appropriate to Juneau.

RECOMMENDATION

Staff recommends that the Commission, based on, previously discussed amendments to the draft plan, recommend adoption by the CBJ Assembly.

Project Timeline, Public Participation and Public Meeting Reviews

October 2010 - The project was initiated with a consultant team of Sheinberg Associates, North Wind Architects, Walker Macy and Kittelson Associates.

October thru mid-November 2010 – The consultant team pulled together background information from recently adopted CBJ plans and public project design schematics. They worked with CBJ staff from Community Development, Engineering, Parks & Recreation and Lands Depts, as well as SLAM project staff, to develop opportunities and constraints, as well as initial concept alternatives for land use, infrastructure and planning goals/elements.

November 2010 – Sheinberg Associates conducted 12 one-on-one targeted interviews with land and/or facility owners in the Willoughby District. Discussed plan goals, their property goals/vision, opportunities and constraints of the District.

November 15, 2010 – Sheinberg Associates conducted an afternoon workshop with land and/or facility owners in the District. In addition to the discussion items above, this allowed public and private property owners to share information between one another and for the group to comment on initial goals and concept alternatives for the District.

November 15, 2010 – Sheinberg Associates conducted a public workshop to present initial plan goals and concepts, and facilitated public comment (see attached meeting flyer). Approximately 45 people attended.

November 5 – December 15, 2010 – Project survey posted on CBJ website which received 262 responses. The comments from the November meetings and the survey are summarized in Appendix A of the Plan, pages 82-90.

January 2011 – Presented initial goals and concept alternatives to the PRAC.

February 2011 – Draft plan received for CBJ staff review and comment. Circulated through Community Development, Engineering, Parks and Recreation, Public Works and Lands Depts.

February 2011 – Draft plan delivered to Assembly Lands Committee

May 2011 – Final draft of the Plan presented to Assembly COW and approved for release for public comment.

May 2011 - Final draft of the Plan distributed to land and facility owners within the Willoughby District for comment. No formal comments received but based on personal communications and consultant feedback the Plan was supported.

Mid May thru mid July 2011 – Final draft of the Plan posted on the CBJ website for public comment. Three comments were received.

June 2011 – Public meeting to present final draft of the Plan. Approximately 12 people attended during 80 degree weather. No comments received.

July 2011 – Presented final draft of the Plan to the PRAC, which passed a motion of support to adopt the Plan.

July 2011 – Presented final draft of the Plan to the Affordable Housing Commission, which passed a motion of support to adopt the Plan and submitted a letter of support (attached).

July 2011 – Presented final draft of the Plan to the Juneau Commission on Sustainability, which passed a motion of support to adopt the Plan and submitted a letter of support (attached).

July 2011 – Planning Commission recommended expanding PD-1 parking overlay boundary to match Willoughby District study area boundary. No public comment.

August 2011 – Presented Plan to the Planning Commission for review and recommendation to the Assembly.

September 2011 – Assembly adopted PD-1 parking overlay boundary expansion. No public comment.

January 2012 – SLAM/DOTPF project team scheduled to present their project design and concepts for off-site infrastructure improvement projects, primarily on CBJ land/facilities and as identified in the Plan, to Assembly COW.

January 2012 – SLAM land use permits scheduled for review by Planning Commission.



Willoughby District Land Use Plan









The City and Borough of Juneau is working on a Land Use Plan for the Willoughby District. This area is roughly bounded by Gold Creek, Egan Drive, Willoughby Avenue and Village Street. For decades Juneau residents have envisioned this as the arts, cultural and civic district.

The Willoughby District Land Use Plan will build on direction established in Juneau's Comprehensive Plan.

The Willoughby District Land Use Plan will attempt to bring vitality and cohesiveness to the Willoughby District by defining and improving public walkways, plazas and streets; identifying spaces for street level retail and dining, and continued development of civic, cultural and residential uses.

Ideas for Plan goals include:

- Strengthen this dynamic center for government and legislative activities, public and civic gatherings, cultural and entertainment events, and residential and commercial activity.
- Improve pedestrian connections to, and through, the District.
- Make the area less chaotic and develop a stronger sense of place, design and landscaping.
- Build more residential units.
- Do a better job of coordinating and sharing parking needs and spaces. Increase use of public and non-motorized transportation and use of the nearby Transit Center.
- Provide public space that compliments and enhances the value of the area's private and public buildings and uses.
- Do a better job of interpreting and celebrating area history.
- Strengthen and support the Alaska State Capitol.

Schedule

This is a fast-paced project. Fortunately there is a lot of good work to build upon. The project got underway in early October 2010.

Between October and mid-November the project team is working with the City and Borough of Juneau to develop a series of Concept Alternatives for the Willoughby District. Alternatives will build on existing plans and will present a range of practical elements and options. Initial public comment through an online (or paper) survey, outreach to those who use, live or work in the District, and some community presentations are occurring.

There will be a public workshop on November 15 to present the alternative concepts and get assistance from the community in reviewing the concepts.

Using public input, the final concept will be selected and refined. We hope to have a plan ready to recommend to the CBJ for Planning Commission review by the end of 2010.

Attend the November 15 Public Workshop

There will be a public workshop on Monday, November 15th, 2010 from 6:30 pm to 8:30 pm at the Juneau Arts and Cultural Center (JACC) at 350 Whittier Street. At this meeting the District's historic context, area planning goals, and a few development concept alternatives will be presented for community review and discussion.

SUBJECT: Willoughby District Land Use Plan

The Affordable Housing Commission endorses the Willoughby District Land Use Plan based on the opportunities in the proposal to provide more housing for the residents of Juneau.

The Willoughby Plan indicates a great potential to increase the number of dwelling units in the area from 120 units to approximately 400 units at future build out.

The Commission would like to remind the Assembly that the 2010 Juneau Housing Needs Assessment reports that the community has a *current* need of 343 units to meet a basic threshold that would allow for more availability and affordability of housing in the community.

The Willoughby Plan offers an opportunity to make up some of this deficit and provide affordable, market-rate rental, single-family residences, and other mixed-use options that are all needed in our community.

In a review of the Willoughby Plan, the Commission has a few comments:

- It is important that the City and Borough of Juneau (CBJ) ensure a wide range of housing opportunity in this district, paying close attention to affordable housing options;
- The Commission encourages the CBJ to pursue the financial incentives for the Implementation stage offered in Table 5 (pg. 71), as well as to use other financial instruments that the City may have at its disposal that are not listed;
- A key component of the provision of affordable housing is the ability to mitigate energy costs so the opportunity to provide ground source heating in the Willoughby District is appealing; and
- The Commission encourages the pursuit of public-private partnerships that will be looked upon favorable by state and federal funders and provide the chance for targeted investment into the housing stock in our community.

The Commission looks forward to the adoption of the Willoughby District Land Use Plan and the opportunity to serve as a resource during the Implementation phase. The Commission stands ready to assist the Assembly in investigating other incentives.

The Juneau Commission on Sustainability (JCOS) is pleased to comment in support of the Willoughby District Land Use Draft Plan.

Of particular interest to the JCOS is the possibility for a district heating and energy distribution project as discussed in Section 4.0 of the Draft Plan. We are encouraged that the plan identifies potential alternative energy sources for the project such as a bio-mass based steam plant or a water-based heat exchange system. The JCOS strongly recommends that the CBJ implement the proposed feasibility study to determine what is the best, most low-impact and sustainable alternative energy source that will benefit both the Willoughby District and the larger community.

The JCOS also supports the key themes that characterize the desired outcomes of the Willoughby District Land Use Plan: (1) the District as the heart of Juneau's civic, arts and cultural campus; (2) enhanced public space; (3) an increase in residential units; (4) a walkable commercial area; and (5) breaking up the "super-blocks" into a grid of "human-scaled" streets and wide sidewalks. Among other things, a sustainable community is one that is well-planned and one where people want to live and work. The Willoughby District Land Use Plan represents the type of development opportunity that can contribute to a sustainable economy and to a high quality of life for Juneau citizens. We look forward to its implementation.

SUBJECT: Willoughby District Land Use Plan – Title 49 Committee Review

The Title 49 Committee has reviewed Chapter 5 of the Willoughby District Land Use Plan. The Committee forwarded a recommendation for adoption of Chapter 5 of the Plan to the Planning Commission, with the edits summarized below:

- 1. The Plan references bonus points in multiple locations. Several edits are needed to accommodate the potential for other regulatory tools, such as an overlay district, or dimensional standard changes, that may be implemented through code amendments to Title 49. These edits are included on:
 - Page 39
 - Page 41 Figure 5
 - Page 44
 - Page 52
 - Page 66
 - Page 67 & 68 Table 4
- 2. One of the primary themes and development goals of the Plan is to create a connected grid of streets and wide sidewalks, to break up the 'super blocks' in this area. During the development phase of the Plan, the consultant team received feedback from the Salvation Army requesting that a new street not be represented through their property (Building 39, Figure 7). The compromise was to include a pedestrian connection instead. The Title 49 Committee supports a street and sidewalk connection in this location, rather than a pedestrian connection, as it forwards the goal of developing a street and sidewalk network. This concept is included on:
 - Page 45 Figure 6 (changing the green identifier to purple)
 - Page 48 Figure 7 and Alternate A (depicting a street and sidewalk south of Capitol Ave rather than a pedestrian connection)
 - Page 49 Figure 8 (if this change is approved for figures 6 & 7, it will apply to Figure 8)

- 3. Changes to language selection, to better represent the intent for the Plan to be flexible.
 - Page 46
 - Page 51 Table 1 title change
 - Page 59
 - Page 60
 - Page 64
 - Page 65
- 4. The Committee discussed a desire for particular attention to be given to future development and improvement in and around the Indian Village. During the development phase of the Plan, the consultant meet with Central Council Tlingit Haida Indian Tribes of Alaska and Village Street residents to receive input and feedback on the Plan. The Title 49 Committee supported the idea of doing more involved, in depth work in this neighborhood, such as through a mini-area neighborhood plan.
