Here's how you find what you are looking for in City code:

- go to http://www.juneau.org/law/codeinterface.htm
- in the window at the left, scroll down to 49.25
- click on "Article III"
- scroll down until you see a actual table of permissible uses (TPU)
- continue to scroll down into the table until you get to "4.150, rock Crusher"
- you will see 1Q in the column for D3
- at the very bottom of the table you can find the footnotes and Q indicates that a crusher in land zoned D3 ...

"Must be in conjunction with an approved state or municipal public road construction project, and must be discontinued at the completion of the project. Road construction by private parties for subdivision development is excluded except as provided in this title. Rock crushed on-site must be used on-site. Crushing shall be limited to 8:00 a.m.—5:00 p.m. unless the director authorizes otherwise."

I don't see in the application where there is any mention of a public road construction project involved. Also, the applicant is asking for extended hours.

I am particularly concerned about the drainage plan, since we can all see the problem created by drainage through the borrow pit on the east side of Montana Creek Road.

I have not yet found anything in the code or TPU that addresses dumping of stumps or control of the resulting odors from decay and decomposition, but this should be addressed in the staff report.

I am also concerned about noise and dust. Because there is no noise ordinance yet in place, I do not know where to look on the first issue. I would think we would need some kind of base level readings on noise in adjacent neighborhoods now, with an expectation that they will not increase more than X decibels during operations. The 1997 noise study from Coogan does not reflect current conditions and should be redone. Helicopters traffic has increased substantially from then and we also have the rifle and shotgun ranges the current pit noises (including the occasional automatic weapons). On the second, dust is a health issue for the elderly and people with certain lung conditions. How this will be limited and/or mitigated is also a question we would look to the staff report to address.

The effect of increased truck traffic on the already deteriorating Montana Creek road must be considered.

On one side of the debate the shortage of buildable land/affordable housing (D3 in this case) is often heard and here they want to mine some residential land and turn it into a pit.

I also share Michelle's frustration of not being able to review the staff report until the last minute.

# Planning Commission Members:

I would appreciate if the Planning Commission allow more time for the public to comment. If you can delay your hearing or at least delay your decision, this will be greatly appreciated. I am the neighborhood rep and am still trying to get this information to our neighbors and Community Garden members.

I would also like to add the following comments after discovering new information yesterday about the City Code.

#### Rock Crusher:

I strongly object to proposed use of a rock crusher (very noisy heavy equipment) next to populated residential property—we currently have about 300 homes in this area. Our neighborhood was originally a rural urban D1 area, however over the past 15 years it has been rezoned D3 and is one of the few growing residential areas in Juneau. There are two more housing phases planned for this area (Bicknell and Glacier Lands), which could add another 150 homes.

There is city code that specifically discusses rock crushers. When I read this code, use of a rock crusher is not allowed to be permitted nor compatible in our D3 residential neighborhood.

According to the City Code 49.25 Art III, 4.150 The allowable use of a rock crusher in land zoned D3 residential "Must be in conjunction with an approved state or municipal public road construction project, and must be discontinued at the completion of the project. Road construction by private parties for subdivision development is excluded except as provided in this title. Rock crushed on-site must be used on-site. Crushing shall be limited to 8:00 a.m.—5:00 p.m. unless the director authorizes otherwise."

However, I was informed by Beth McKibben that it has been determined by the Director of Community Development to allow the use of a crusher under the more generic language: 49.65.200 Extraction permit required.

(a) The use of property for the excavation, removal or other extraction of stone, sand, gravel, clay or other natural deposits and formations, including the processing of the materials, may be authorized in any district only under a conditional use permit issued by the Commission under the procedures set forth in chapter 49.15, article III, as modified by this article. (Emphasis Added)

This is unacceptable and possibly illegal for the City to use this generic language when specific City Code has been written to address the use of rock crushers in residential areas. This is the reason why the permit application was pulled last fall because the operation of a rock crusher is not allowed in a D3 area. However, the Director has decided to ignore the specific city code in order to appease Coogan Construction.

#### Long hours of operation

his is a residential area and the hours of operation should be limited to Monday — Friday 8-5. Operating on Saturdays is unacceptable for our neighbors along with those enjoying the Community Garden next door and all of those Juneau residents who recreate at Mendenhall lake and campground.

#### Inadequate water drainage plans

The proposal only plans to build a ditch to the SW corner to divert water, which will eventually flow into Montana Creek. This seems extremely inadequate. I encourage the City to require a water drainage treatment and monitoring plan. Prevention of allowing petroleum products, heavy metals and disturbed water from entering Montana Creek and

impacting that highly valued community fishery is necessary. If this problem can be avoided on the Coogan's gravel pit, Drainage and water treatment are necessary for projects that have impacts to other water bodies.

No long term reclamation plan--Overburden (stumps) and organic material Our neighborhood has been dealing with the obnoxious rotting egg smell from the gravel pit at Glacier Lands for the past several years. We have been informed that when the water level falls in the winter and exposing the rotting stumps and organic material dumped into the pit over the years, it releases a foul sulfur odor. This situation needs to be avoided at Coogan's gravel pit. Stumps should not be allowed to be stockpiled and then dumped in the pit. What is the long term reclamation plan? I encourage you to be proactive and plan for the future of this gravel pit and the surrounding uses.

#### Traffic

I disagree that there will be no significant impact to Montana Creek road and traffic. Again this is a residential area with kids on bikes and a lot of general traffic, which do not mix well with large hauling trucks.


One particular concern is the large dump trucks. Those large trucks don't belong in this neighborhood, let alone traveling at 30 miles per hour.



Stockpile areas, equipment storage, maintenance building and processing areas need to be shown.

Final site elevations shall be delineated.

Label the existing topographic lines at the edge of the property along the west and southerly boundary. Elevations are not clear.

The location of drainage ditches, swales and vegetated berms that will constructed and remain as stormwater quality control shall be shown on the restoration plan. The use of hay bales is not acceptable as a stormwater quality method. Rock check dams and filter fabric are required. The plan shall also detail the inspection and maintenance of the stormwater control devices.

Site plan states the right of way is not dedicated. The Right of Way was dedicated per plat 2003-27 as Montana Creek Road. A plan shall be submitted that shows how the site access will be reconstructed to prevent mud, sediment laden water and other debris from truck traffic entering the right of way, including roadside ditches.



Thanks for the note. Here's what we sent to our respective supervisors over here at DEC.

Jill Weitz (ADEC) conducted four site visits to the complaint area across from Skater's Cabin on Montana Creek Road. Three turbidity water samples were taken from the drainage ditch during low flow conditions. Meter analysis demonstrated samples were within Alaska Water Quality Standards. Three Fecal Coliform samples were taken from the drainage ditch and analyzed at Admiralty Environmental, with results within Alaska Water Quality Standards. Copies of the results have been provided to City and Borough of Juneau (CBJ) for review.

On Wednesday, February 23<sup>rd</sup>, Brock Tabor (ADEC) and Jill Weitz met with CBJ representatives and conducted both visual inspections and dye studies on the adjacent lift station, finding no system failure. A strong sulfuric scent was noted from the drainage leaving the private gravel pit but water clarity or composition was not determined to be an issue. The presence of iron floc (hydrated ferric oxide) was noted but is consistent with other streams in the Juneau area. The musty/sulphur scent is attributed to the bacteria feeding on the iron floc.

Iron bacteria are a diverse group of micro-organisms widely distributed in nature. They are found in fresh and salt waters, in soil and on desert rock surfaces. Iron bacteria are morphologically and physiologically heterogeneous, having the ability to transform significant amounts of iron into obnoxious slimes. However iron bacteria are not the only producers of bacterial slimes. The large amount of brown slime produced will have a reddish tinge and an unpleasant odor to drinking water, and may be unsuitable for domestic and industrial use. Iron bacteria metabolize reduced iron present in their aqueous habitat, and deposit it in the form of hydrated ferric oxide on or in their mucilaginous secretions.

Discussion between ADEC and CBJ concluded that the odor is related to naturally occurring decomposition of organic material and metabolized Iron. According to CBJ, this same condition is noted in several locations in the Valley area.

CBJ has agreed to provide a memo to the CBJ Assembly and interested members of the public on the situation.

#### SUBJECT: MENDENHALL VALLEY RANK ODOR COMPLAINTS

In mid January, General Engineering and Public Works began receiving complaints of a rank odor defined by the citizens as "SEWER SMELL". The complaints came from several different locations throughout the Mendenhall Valley. Citizens that live on Wren Drive, Aspen, Duran Ct, Dredge Lake, Dogwood, Valley Blvd, Portage Blvd, Kanat'a and Marion Drive all contacted the CBJ with complaints. GE also received a complaint from a Horizon Drive home owner (Bayview) claiming the smell is so bad that sewer system must be leaking.

I discussed the issue with Tom Trego and we agreed that the odor is permeating from an organic layer of material that was actuated from the recent freeze-thaw cycles we are experiencing in Juneau. However, for verification wastewater crews spent several hours investigating the complaints finding **no issues with the wastewater systems.** 

On February 10<sup>th</sup>, I received an email from Jill Weitz, Environment Program Specialist, ADEC, stating that there had been several complaints from the citizens who lived in the Skater's Cabin area; "Extreme odors and effluent are coming from the rock pit near the entrance to the campground". I responded with the previously proven conclusion by wastewater that the odor is from Mother Nature, not leaking fecal matter. However, since the outfall is in close proximity to the Skater Lift Station we agreed to a site visit.

At the site it was determined that the odor permeated from organic matter decomposing and there is no health risk. The theory was verified by the ADEC water samples from the pit underdrain outfall and roadside ditch that were processed by Admiralty Environmental (See Attached).

Yesterday morning, I received another email from ADEC. Several citizens in the Skater's Cabin neighborhood were experiencing the rank odor. The email also contained a forwarded email from Luke Fanning testifying that some guy from the Forest Service claimed he could see effluent from the lift station flowing into the ditch.

Even though we had a negative test of the runoff water it was decided that Wastewater representatives, Scott Jeffers, Mark Mow, Mike Schwab, ADEC representatives Brock Tabor, Jill Weitz and I would meet at the site to investigate.

Wastewater opened the lift station (which had a very different odor) and poured in a red dye. The lift station ran through a pump cycle and no dye appeared in the ditch below the lift station. The lift station is working correctly and there is no sewage escaping from the system.

All persons attending the meeting agreed that the rank odor was definitely not a wastewater issue. Subsequently, ADEC forwarded an inner office memo that further explains the odor issue.

#### SUBJECT: MENDENHALL VALLEY RANK ODOR COMPLAINTS

In mid January, General Engineering and Public Works began receiving complaints of a rank odor defined by the citizens as "SEWER SMELL". The complaints came from several different locations throughout the Mendenhall Valley. Citizens that live on Wren Drive, Aspen, Duran Ct, Dredge Lake, Dogwood, Valley Blvd, Portage Blvd, Kanat'a and Marion Drive all contacted the CBJ with complaints. GE also received a complaint from a Horizon Drive home owner (Bayview) claiming the smell is so bad that sewer system must be leaking.

I discussed the issue with Tom Trego and we agreed that the odor is permeating from an organic layer of material that was actuated from the recent freeze-thaw cycles we are experiencing in Juneau. However, for verification wastewater crews spent several hours investigating the complaints finding **no issues with the wastewater systems.** 

On February 10<sup>th</sup>, I received an email from Jill Weitz, Environment Program Specialist, ADEC, stating that there had been several complaints from the citizens who lived in the Skater's Cabin area; "Extreme odors and effluent are coming from the rock pit near the entrance to the campground". I responded with the previous conclusion by wastewater that the odor is from Mother Nature, not leaking fecal matter. However, since the outfall is in close proximity to the Skater Lift Station we agreed to a site visit.

At the site it was determined by observation that the odor permeated from organic matter decomposing and there is no health risk relating to the lift station. The observation was verified by the ADEC water samples from the pit underdrain outfall and roadside ditch that were processed by Admiralty Environmental (See Attached).

February 22<sup>nd</sup> I received another email from ADEC stating that several citizens in the Skater's Cabin neighborhood were experiencing the rank odor. The email also contained a forwarded email from Luke Fanning stating that an unidentified Forest Service employee claimed he could see effluent from the lift station flowing into the ditch. In addition I received a forwarded copy of the email you sent to Brock and Rod expressing your concerns.

Even though the runoff water had been tested with a negative result it was decided that Wastewater representatives, Scott Jeffers, Mark Mow, Mike Schwab, ADEC representatives Brock Tabor, Jill Weitz and I would meet at the site to investigate.

Wastewater opened the lift station (which had a very different odor) and poured in a red dye. The lift station ran through a pump cycle and no dye appeared in the ditch below the lift station or along the force main that runs to Montana Creek Rd. The lift station is working correctly and there is no sewage escaping from the system. It should be noted that Wastewater inspects all lift stations routinely, most cases daily.

All persons attending the meeting agreed that the rank odor was definitely not a wastewater issue. Subsequently, ADEC forwarded an inner office summary that further explains the odor issue (attached).

I should also note, in reference to your email, that the lower outfall pipe from the pit is an underdrain constructed several years ago that manages runoff from the forest property to the north and is not a pumping operation (it flows year around). A second pipe is connected to an overflow basin in the pit that releases water to stop the pit water from overtopping the embankment. To my knowledge there has **never** been water pumped into the roadside ditch that directs flow into Mendenhall Lake.

I hope this answers your questions and you are assured that the CBJ wastewater infrastructure does not produce the rank odor that is the subject of area wide complaints.
