#### **PROJECT DESCRIPTION**

The applicant, DCS Tower Sub, LLC. (DCS), requests to continue a lease with CBJ at the West Juneau reservoir site to allow for the continued use of DCS's existing wireless communications tower/facility.

#### BACKGROUND

DCS has applied to lease approximately 3,200 square feet of CBJ land at the West Juneau reservoir site to allow for continued use of DCS's existing wireless communications tower and facility. The existing 180 foot tall tower was originally approved with Conditional Use permit CU-31-95. The 180 foot tall tower includes an accessory control building.

#### ANALYSIS

The subject site is located at the end of Jackson Road at the West Juneau reservoir site near the existing water tower. The Dan Moller Trail parking lot is located nearby (See Attachment A). There are currently four towers located in the vicinity of the Water Tower. The current owners of the towers are AEL&P; ACS; White Oak Towers of Alaska, Inc.; and DCS Tower Sub, LLC. These four towers were approved by individual Conditional Use permits.

The proposed lease terms and conditions for the DCS lease are similar to those recently approved by the Assembly for the ACS tower at the same site (CSP2011 0006). The new lease document will update rent and bring terms and conditions in line with current CBJ leasing practices. The lease would be for a term of five years and allow for three five-year renewals. Subleasing would be allowed based on a revenue sharing schedule in which DCS would share a percentage of rent it collects from its sublessees with the CBJ. DCS's current business plan involves renting space on its tower for equipment owned by various service providers. Other terms of the lease would limit use of the site to maintaining, repairing, operating, and leasing a communications tower/facility. The Lessee shall ensure all equipment and activities on the leased premises operate in a manner which will not cause unreasonable interference with the operations of the CBJ or other authorized users in the vicinity of the leased premises.

According to the Land Use Code section 49.10.170(c) *City and borough land acquisitions, disposals, and projects,* "The commission shall review and make recommendations to the Assembly on land acquisitions and disposals as prescribed in title 53, or capital improvement project by any City and

Borough agency. The report and recommendation of the commission shall be based upon the provisions of this title, the comprehensive plan, and the capital improvements program."

This lease requires a consistency review to ensure that the proposed project is consistent with adopted plans.

## **CONFORMITY WITH ADOPTED PLANS**

The project was reviewed for consistency with the 2008 Comprehensive Plan (Plan). The Plan designates the site as Urban Low Density Residential (ULDR).

#### Urban Low Density Residential

These lands are characterized by urban or suburban residential lands with detached singlefamily units, duplex, cottage or bungalow housing, zero lot-line dwelling units and manufactured homes on permanent foundations at densities of one to six units per acre. Any commercial development should be of a scale consistent with a single-family residential neighborhood.

Though the site does not consist of any residential dwellings or uses, it has become a popular site for telecommunication infrastructure. These towers have been constructed next to a water tank and will not likely affect any future development.

The Plan does not speak directly about telecommunication towers or related infrastructure. However, given Juneau's remoteness and the location of the Capitol, it is critical to maintain adequate telecommunication technology and service.

Staff finds the continuation of an existing tower in an area used by other telecommunication carriers an appropriate land use, and is consistent with the Comprehensive Plan.

Towers are identified as a permissible land use in the Rural Reserve zoning district, as noted in the Land Use Code. Those that are over 50 feet in height, such as this one, require an approved Conditional Use permit, which this one received in 1995. Towers must also meet all yard setback requirements. The height of towers is not restricted to the building height. The subject tower is complies with the required setbacks. It is not near any dwelling or privately-owned commercial buildings, other than adjacent auxiliary buildings (sheds). Therefore, it will not endanger nearby buildings in case of collapse.

#### **HABITAT**

The proposed lease area will not affect any mapped sensitive environments. The tower and accessory control building are already constructed and exist.



#### CITY/STATE PROJECT REVIEW REQUIREMENTS

Each application for a City/State Project is reviewed by the Planning Commission at a public hearing. The permit procedure is intended to provide the Commission the flexibility necessary to make recommendations tailored to individual applications.

Application: An application for a City/State Project Review will not be accepted by the Community Development Department until it is determined to be complete. The items needed for a complete application are:

Forms: A completed City/State Project Review Application form and Development Permit Application form. The "land owner or lessee consent" signature is <u>mandatory</u> for all landowners on the Development Permit Application form.

Fees: No fee required for projects that cost less than \$2.5 million. For projects costing more than this amount, the fee is \$1,600.00. All fees are subject to change.

Project Description: A detailed letter or narrative describing the project.

Plans: All plans are to be drawn to scale and clearly show the items listed below:

- A. Plat, site plan, floor plan and elevation views of existing and proposed structures and land;
- B. Existing and proposed parking areas, including dimensions of the spaces, aisle width and driveway entrances;
- C. Proposed traffic circulation within the site including access/egress points and traffic control devices;
- D. Existing and proposed lighting (including cut sheets for each type of lighting);
- E. Existing and proposed vegetation with location, area, height and type of plantings; and,
- F. Existing physical features of the site (i.e. drainage, eagle trees, hazard areas, salmon streams, wetlands, etc.)

**Document Format:** All information that is submitted as part of an application shall be submitted in either of the following formats:

- A. Electronic copies may be submitted by CD, DVD or E-mail in the following formats: .doc, .txt, .xls, .bmp, .pdf, .jpg, .gif .xlm, .rtf or other formats pre-approved by the Community Development Department.
- B. Paper copies may not be larger than 11" X 17" (Unless a larger paper size is preapproved by the Community Development Department).

Application Review & Hearing Procedure: Once the application is determined to be complete, the Community Development Department will initiate the review and scheduling of the application. This process includes:

**Review:** As part of the review process the Community Development Department will evaluate the application for consistency with all applicable City & Borough of Juneau codes and adopted plans. Depending on unique characteristics of the permit request the application may be required to be reviewed by other municipal boards and committees. Review comments may require the applicant to provide additional information, clarification, or submit modifications/alterations for the proposed project.

Hearing: All City/State Project Review Permit Applications must be reviewed by the Planning Commission. Once an application has been deemed complete and has been reviewed by all applicable parties the Community Development Department will schedule the requested permit for the next appropriate meeting. The Planning Commission will make a recommendation based on staff's analysis and forward it to the Assembly for final approval/denial.

The Planning Commission is requested to review and make a recommendation to the Assembly on an application by DCS Tower Sub, LLC (DCS) to lease approximately 3,200 square feet of CBJ land at the West Juneau reservoir site to allow for continued use of DCS's existing wireless communications tower/facility.


This application is similar in nature to the wireless communications tower/facility the Planning Commission favorably reviewed late last year for ACS Wireless Inc. at the same reservoir site.

#### Construction of the Water Reservoir and Towers on State Land

In the mid-1980s the CBJ constructed a water reservoir on State land located above the Blueberry Hills Subdivision in West Juneau. The water reservoir was authorized by Right-of-Way Permit ADL 104284, issued by the DNR. Soon after, other entities began expressing an interest in co-locating various communication towers at the site. Over the span of several years, and after consulting with the CBJ, the State ultimately issued four permits/easements to allow for the construction, maintenance and operation of communication towers.

#### Transfer of Land to CBJ

The CBJ selected the land at the West Juneau reservoir site as part of its municipal land entitlement from the State of Alaska. The State transferred management authority for the land, including administration of the four tower permits/easements, to the CBJ in 2003.



The current owners of the four towers are: AEL&P; ACS; DCS Sub, LLC; and White Oak Towers of Alaska, Inc.

## History of the DCS Tower/Facility

Construction of the existing DCS tower/facility was the outcome of an easement developed in 1996 between the State of Alaska (as landowner/grantor) and AK 03 Cellular Corporation d/b/a CellularOne (as grantee). In the ensuing years, the CBJ selected the subject land from the State of Alaska and the CBJ now has full management responsibilities for the site. DCS has assumed control of the tower easement from CellularOne.

DCS's current business plan involves renting space on its tower for equipment owned by various service providers. The State-issued easement did not address this sort of subleasing arrangement. Given that subleasing is an essential part of DCS's business plan as well as the fact that its current easement is set to expire in 2016, DCS is eager to enter into a new, longer leasing arrangement with the CBJ, one that accommodates subleasing. The CBJ, in turn, will benefit from the revenue-sharing formula in the new lease. Additionally, the more robust terms of the lease will better protect the CBJ's interests at the site.

#### **Department Review**

The Public Works, Engineering, Community Development, Parks and Recreation and Police departments were consulted and invited to comment on the proposed lease; there were no objections to DCS's continued use of the site for its communications tower.

### Lease Terms and Conditions

The proposed lease terms and conditions for the DCS lease are similar to those recently approved by the Assembly for the ACS tower at the same site. The new lease document will update rent and bring terms and conditions in line with current CBJ leasing practices. The lease would be for a term of 5 years and allow for 3 five-year renewals. Subleasing would be allowed based on a revenue sharing schedule in which DCS would share a percentage of rent it collects from is sublessees with the CBJ. The use of the site would be for the purpose of maintaining, repairing, operating, and leasing a communications tower/facility. Lessee shall ensure all equipment and activities on the leased premises operate in a manner which will not cause unreasonable interference with the operations of the CBJ or other authorized users in the vicinity of the leased premises.

## Planning Commission Review and Recommendation

The Lands and Resources staff request this lease application be reviewed by the Planning Commission and that the Planning Commission's recommendations be forwarded to the Assembly.
