

#### **BACKGROUND**

The Pederson Hill area rezone was initiated by Community Development staff. The area is classified as a transition zone, D1(T)D10, and sewer installation was completed in the Fall of 2010. When looking at the map it made sense to staff to review rezoning the region in two phases. The first area, which the Planning Commission acted on in June 2011, was the area around the Wildmeadow Subdivision. The second area, parallel to Glacier Highway on Pederson Hill, (attachment B) is the subject of this staff report. When reviewing attachment B you will notice two areas that are identified as not transitioning to D10 zoning. The area to the northwest was not served with sewer and is therefore not currently eligible for the transition. The area in the southwest is a lot that split into two zones, D1(T)D10 and D1(T)D3. Staff has spoken with the property owners and they desire rezoning the entire lot, but because the lot is split into two different transition zones and two different land use designations on the comprehensive plan maps it was decided to address this separately.

#### Discussion

The area discussed in this staff report is currently zoned D1(T)D10. CBJ§49.70, Article VII addresses Transition Zones. CBJ§49.70.700 states that a transition zone is an overlay zoning district for certain lands that are set aside for higher density development after public water and sewer have been provided. It further states that the increase in density will take place at the time public services are provided. As stated previously, public water has been available for some time, and public sewer installation was completed in Fall of 2010.

CBJ§ 49.25.210 (a) describes the D-1 zoning district as follows:

The D-1, residential districts, is intended to accommodate primarily single-family and duplex residential development in areas outside the urban service boundary at a density of one dwelling unit per acre. Certain D-1 zoned lands, however, may exist within the urban service boundary in transition areas if public sewer or water are absent but planned for. The D-1 classification will be changed to a higher density upon delivery of these services.

CBJ§ 49.25.210 (c) describes the D-10 zoning district as follows:

The D-10 and D-15, residential districts, are intended to accommodate primarily multi-family residential development at ten to 15 units per acre respectively. These are relatively low-density multi-family districts.

The 2008 Comprehensive Plan (map F) shows the area as RDR(T)MDR. This is Rural Dispersed Residential Transition to Medium Density Residential.

The plan describes RDR (page 163) as follows:

These lands are characterized by dispersed, very low density development not provided with municipal sewer or water. Densities are intended to permit one dwelling unit per acre or larger lot sizes, based on existing platting or the capability of the land to accommodate on-site septic systems and wells. Uses may also include small-scale, visitor-oriented, seasonal recreational facilities.

## MDR is described as follows:

These lands are characterized by urban residential lands for multi-family dwelling units at densities ranging from 5 to 20 units per acre. Any commercial development should be of a scale consistent with a residential neighborhood.

There are 49 lots in this area. Two of which are owned by CBJ. The 47 privately owned parcels range in size from 0.23 acres to 4.63 acres. The minimum lot size in the D-10 district is 6,000 square feet. Many of the lots are large enough that they might be subdivided in the future. Two lots will be split into two zoning districts. One is the 13.87 acre site owned by the LDS Church. Of this site 3.9 acres adjacent to Glacier Highway are to transition to D10. The rest will remain D1(T)D3. Given the topography and development plans it does not seem appropriate to transition the entire lot to D10 and doing so would not be consistent with the maps of the comprehensive plan. The other is a 231 acre CBJ owned parcel, of which 10.6 acres are to be transitioned to D10. This lot is split on the zoning map with 10.6 acres in the D1(T)D10 zone and the remainder in D1(T)D5. It is not split on 2008 Comprehensive Plan maps. However, if we were to rezone the portion of the lot currently identified to transition to D5 to some zone other than D5 it would require Assembly approval. We are proposing to follow the zoning map and create a split lot zone.

The 1997 Juneau Wetlands Management Plan categorizes wetlands into four categories; A, B, C and D; with A being of the highest value and D the lowest. The Wetlands Management Plan maps shows small areas of this area as having a wetlands classification of C and D.

The CBJ Division of Lands and Resources had a study completed that evaluates access (utilities and roads) and development potential (slopes, wetlands etc) for the area known as Pederson Hill. The study evaluated CBJ and University owned land uphill from the region discussed in this staff report. A rezone request is expected at some time in the future to facilitate development at a higher density than D-1.

On March 19, 2012 staff held a neighborhood meeting with the owners of property within the D1(T)D10 area. The primary purpose of the meeting was to let property owners know that staff was working on transitioning the area from D-1 to D-10. Owners of four privately owned

parcels attended the meeting. Some of the owners of privately owned parcels expressed a desire to <u>not</u> have the area rezoned. Others noted that the transition to higher density after the sewer installation had been discussed for many years.

#### **ANALYSIS**

# **ZONE CHANGE INITIATION**

CBJ §49.75.110. INITIATION. A rezoning may be initiated by the director, the commission or the assembly at any time during the year. A developer or property owner may initiate a request for rezoning in January or July only. Adequate public notice shall be provided by the director to inform the public that a rezoning has been initiated.

1. Was the proposed zone change initiated by the property owner during the appropriate time frame? OR was the zone change initiated by the commission or director?

Yes. The application for the subject zone change was initiated by the director.

2. Has the director provided adequate public notice through newspaper advertising, property owner mailings and requiring a public notice sign to be posted on-site?

**Yes.** The public was notified through newspaper advertising published on November 2, 2012 and November 12, 2012, mailings to owners of all properties within 500 feet of the subject property, and a public notice sign posted on-site for two weeks prior to the Planning Commission hearing on the rezone request.

# 49.70.900-49.70.1097 COASTAL DEVELOPMENT, HABITAT, AND WETLANDS JUNEAU COASTAL MANAGEMENT PROGRAM (ACMP)

**Not applicable.** Rezoning does not require permits that might be required through the JCMP. Permits for construction will address these issues when specific projects are proposed.

# RESTRICTIONS AND PROCEDURE

CBJ§49.70, Article VII addresses Transition Zones. CBJ§49.70.700 states that a transition zone is an overlay zone district for certain lands that are set aside for higher density development after public water and sewer have been provided. It further states that the increase in density will take place at the time public services are provided. As stated previously, public water has been available for some time, and public sewer installation was completed in the Fall of 2010.

CBJ §49.75.120. RESTRICTIONS ON REZONINGS. Rezoning requests covering less than two acres shall not be considered unless the rezoning constitutes an expansion of an existing zone. Requests which are substantially the same as a rezoning request rejected within the

previous twelve months shall not be considered. A rezoning shall only be approved upon a finding that the proposed zoning district and the uses allowed therein are in substantial conformance with the land use maps of the comprehensive plan.

The CBJ Land Use Code provides minimum restrictions for zone change requests. This proposal conforms to these restrictions as follows:

- 1. The request is more than 2 acres.
- 2. No similar request has been made in the past year.

The transition zone as shown on the zoning maps is consistent with the maps of the 2008 Comprehensive Plan. It is also consistent with the currently proposed draft map of the 2013 Comprehensive Plan update.

#### LAND USE

Most developed private property in the area is single family residential, but much of the area is currently undeveloped. There are several churches in the area. Churches require a conditional use permit in both the D1 and D10 zoning districts. Swampy Acres is included in this transition area and will become a non-conforming use with this transition.

#### **COMPREHENSIVE PLAN**

The area is located within Subarea 4. The Comprehensive Plan map designation of the area is RDR(T)MDR, This is Rural Dispersed Residential Transition to Medium Density Residential.

The plan describes RDR (page 163) as follows:

These lands are characterized by dispersed, very low density development not provided with municipal sewer or water. Densities are intended to permit one dwelling unit per acre or larger lot sizes, based on existing platting or the capability of the land to accommodate on-site septic systems and wells. Uses may also include small-scale, visitor-oriented, seasonal recreational facilities.

#### MDR is described as follows:

These lands are characterized by urban residential lands for multi-family dwelling units at densities ranging from 5 to 20 units per acre. Any commercial development should be of a scale consistent with a residential neighborhood.

In Chapter 11, Comprehensive Plan Land Use Maps (pg 159) the following guidance is made in regard to rezoning:

In considering re-zoning request, the Planning Commission and Assembly should aim to promote the highest and best use of the land under consideration: in some cases, the highest and best use may be increased density or more intensive use of the land; in other cases, the highest and best use may be preservation in an undisturbed state for purposes of habitat preservation, flood control, or providing a buffer between development and areas subject to natural hazards.

Clearly the land use maps of the Comprehensive Plan are not hard and fast, there is some flexibility in review. Page 1, paragraph 5 of the 2008 Comprehensive Plan

"Discussions related to community growth, redevelopment, capital and social improvements, or budget, must occur in consultation with the Plan. This is not to say that the Plan will be infallible or that it is cast in concrete. It should, however, bring into focus sufficient information and data so that the best possible considered and objective judgments can be made, using the most current data available when the data in the Plan is out of date."

Page 202 of the Comprehensive Plan contains the guidelines and considerations for Subarea 4. The most relevant of these is the first which states:

Maintain the density of existing neighborhoods while encouraging in-fill development of low to moderate income affordable housing.

#### **ACCESS AND TRAFFIC**

Access to the area is from Glacier Highway, a state right of way which is classified by CBJ as an arterial. Most of the smaller lots directly access small neighborhood streets (Hamilton and Wilma) that then access the highway. Rezoning the area may result in some traffic increase with future development. However, this is not anticipated to be problematic. Future subdivisions will be required to provide new roads so that lots do not have access directly on to the arterial.

#### **SUMMARY**

The zoning maps showing the area transitioning to D-10 are consistent with the maps of the 2008 Comprehensive Plan.

#### **FINDINGS**

After review of the application materials, the CBJ Land Use Code, and the CBJ 2008 Comprehensive Plan the Director makes the following findings:



- 1. The proposal meets the submittal requirements and the rezoning initiation, zone change restrictions and procedural requirements of the CBJ Land Use Code.
- 2. This proposal is consistent with the Land Use maps of the Comprehensive Plan specifically Map F.
- 3. The rezoning is larger than 2 acres.

### STAFF RECOMMENDATION

Staff recommends that the Planning Commission adopt the Director's analysis and findings and take the following actions:

1. Approve the zone upgrade to D-10 as shown on attachment A.
































#### NOTICE OF NEIGHBORHOOD MEETING FOR PROPOSED RE-ZONE

Dear Resident,

Your lot is zoned D-1(T)D-10. This means it is intended to become a higher density zoning when public utilities are made available. As you know, sewer was recently extended to your area. The CBJ Planning Commission requested staff to begin the process of transitioning this area from D-1 zoning to D-10.

The CBJ Community Development Department is hosting a neighborhood meeting to explain the details and the CBJ review process. This meeting will be held on Monday, March 19, 2012, 7:00 pm to 8:00 pm in the Mendenhall Valley Library conference room.

The purpose of the March 19th meeting is to provide information, respond to questions, and to get a sense of concerns that the neighborhood might have, so issues may be addressed in advance of the formal public hearing with the CBJ Planning Commission. After the project has been scheduled for review by the Planning Commission (this will most likely happen in April or May), all landowners within 500 feet of the proposed rezone will receive a separate notice with details on how and where to submit comments or testify on the proposal.

# CBJ 49.700 Article VII Transition Zones

- A Transition zone is an overlay zone for certain lands that are set aside for higher density development after public water and sewer have been provided.
- When public services are provided a zoning "upgrade" can be initiated by either an applicant of a major development in the area or by the Planning Commission.
- The Planning Commission is required to hold a public hearing on the proposed zoning upgrade.
- The Planning Commission can approve a zoning upgrade as indicated on the official zoning map (D1 (T) D5).
- A change other than what is shown on the official zoning map must be approved by the Assembly.

D-1 -is intended to accommodate primarily single family and duplex residential development at a density of 1 dwelling unit per acre. limited amount of D-1 zoned lands located within the urban service boundary. These are lands for which a lower density is deemed D-1 zoned lands are primarily located outside the urban service area boundary where public utilities are not provided. There is a appropriate or, in the case of transition zones, where the density will be changed to a higher density when sewer and water are provided. <u>**D-10**</u> residential district is intended to accommodate primarily multi-family residential development at a density of 10 dwelling units per acre. These are relatively low-density multi-family districts.
