The Planning Commission, at a regular public meeting, adopted the analysis and findings listed in the attached memorandum dated August 6, 2013, and found the resurfacing of North Douglas Highway from the roundabout (Juneau-Douglas Bridge) to Fish Creek Road; the replacement of guardrail and signs; and the completion of minor drainage repairs at five locations, consistent with CBJ 49, with the project to be conducted as described in the project description and drawings submitted with the application in accordance with the following conditions:

- 1. Advisory Condition: CBJ 42.20.095(b) Construction of buildings and projects. It is unlawful to operate any pile driver, power shovel, pneumatic hammer, derrick, power hoist, or similar heavy construction equipment, before 7:00 a.m. or after 10:00 p.m., Monday through Friday, or before 9:00 a.m. or after 10:00 p.m., Saturday and Sunday, unless a permit shall first be obtained from the City and Borough building official. Such permit shall be issued by the building official only upon a determination that such operation during hours not otherwise permitted under this section is necessary and will not result in unreasonable disturbance to surrounding residents.
- 2. Advisory Condition: A variance under CBJ 49.20 Article II may be required if construction is proposed to occur within 330 feet of a bald eagle nest.

Furthermore, the Planning Commission requests that State Project ID #25796, North Douglas Bike and Pedestrian Path, have its scoping description modified to read:

"A combination pedestrian and bicycle path along the North Douglas Highway. The existing paved shoulder will be marked as bike lanes and construction of a new sidewalk on one side of North Douglas Highway from the roundabout to the intersection with Fish

Creek Road. Bus pullouts meeting DOT&PF specifications will be included approximately every one-half mile on either side of the road."
