PROPOSAL:

A Text Amendment of Title 49 and of the Comprehensive Plan for an


Auke Bay Area Plan.

The City and Borough of Juneau Code states in CBJ 49.10.170(d) that the Commission shall make recommendations to the Assembly on all proposed amendments to this title, zonings and re-zonings, indicating compliance with the provisions of this title and the Comprehensive Plan.

BACKGROUND

The 2008 Comprehensive Plan of the City and Borough of Juneau (the Plan), Guidelines and Considerations for Subarea 3, call for the development of a small area or neighborhood plan for the Auke Bay area. The Plan provides guidance regarding what the Auke Bay plan should aim to achieve in both process and outcome:

- 1. Conduct an area plan or neighborhood plan for the Auke Bay area that would address residential and non-residential uses in the vicinity of the cove, harbor and University with the goal of creating a Marine Mixed Use, transit and pedestrian-oriented village in Auke Bay. Marine Mixed Use land uses could include: Water-related recreation, ecotourism, commercial fisheries, sport fisheries, marine-related research and aquaculture, and other private and public use of the waters; shoreline and inland areas of Auke Bay including the University of Alaska Southeast (UAS) campus, student and faculty housing, neighborhood commercial needs, transportation systems, habitat protection, educational facilities, careful urban design, and viewscape protection measures...
- 2. Protect and provide for continued water-dependent development at the Ferry Terminal and in Auke Bay. Identify suitable areas for float homes, boat houses, and/or live-aboards as affordable housing options, this may include dedicated portions of the harbor for these residences. Adopt design guidelines and development standards for the proposed Auke Bay neighborhood plan and Marine Mixed Use District.

3. Encourage high-density, transit-oriented residential and/or mixed use developments in the Auke Bay "village" area and around the University, particularly for student and faculty affordable housing.

To initiate this planning process, Community Development Department (CDD) staff have been conducting research and compiling information on the Auke Bay area for several months. Using that baseline data, staff identified potential issues, opportunities, and stakeholders in the Auke Bay area. Stakeholder interviews are being conducted one-on-one by CDD Director Hal Hart, with other CDD staff working on assigned topic areas to ensure that all appropriate agencies are informed of and participating in the planning process.

Public outreach began in earnest with two open house format meetings held at the University of Alaska Southeast (UAS) Glacier View Room on October 15 and 19. Each of these meetings consisted of three presentations followed by question and answer time on an hourly schedule. Seventy-one people signed in at the meetings, but more people attended who didn't sign in. Handouts available to attendees included a housing density map, an Auke Bay area map, and a paper version of the online Auke Bay survey. On the Auke Bay area map, attendees were asked to draw where they think the boundaries of Auke Bay are. Staff and the steering committee will use this information to determine the extents of the planning area.


An on-line survey was open from October 4 through November 4, and had 223 responses. Those responses are attached to this memorandum. Two of the questions, numbers 8 and 9, asked openended questions regarding the "assets" and "problems" in the Auke Bay area. Those responses were input to a program that uses word frequency to determine font size and which creates a graphic representation of the words used to describe the "assets" and "problems" in Auke Bay. Those graphics, although not scientific representations of people's comments, do indicate themes in responses and can be useful in seizing upon major issues quickly; these graphics are included as attachments to this memorandum following the list of all answers to the questions.

During the October 15 and 19 open houses, on the project web site (www.juneau.org/aukebayplan), and in the online survey, applications were solicited for project Steering Committee members. The applications received by noon on Wednesday, October 6, 2013 are attached for your review. Staff requests that the Planning Commission determine the number of seats on the Steering Committee and also select the appropriate number of applicants for seats on the Steering Committee.

RECOMMENDATION

Staff recommends that the Planning Commission review, discuss, and provide feedback on the initial survey results, the plan's goals and process, and select members for the Steering Committee.






- Center to support a growing university

- I envision safe biking and walking paths, places to sit and gather, a seawalk along the waterfront, mixed commercial and residential developments that emphasize a community feel, including affordable retiree housing and "cohousing" attached/garden housing. A large tract of undeveloped acreage behind the elementary school and next to the south edge of the Spauling Meadows trail could possibly accommodate such a "co-housing" area. If the terminus of the bus system is not extended to the ferry terminal (it should be) then a mixed-use bus terminal that has sufficient parking for riders. I'd like to see buildings limited to 4 stories to 1) preserve the view for more people and 2) be consistent with Fire Department ladder size & access. A sea walk/path from the post office area, extending past the Hot Bite would allow the community to enjoy the waterfront while reducing pedestrian & bicycle congestion on the highway. A better tour bus system should be worked out so residents are not shouldered out of access by the growing tourism in Auke Bay. Better lighting for the crosswalks for UAS students & possibly a highway overpass walkway to accommodate the most used sections, like the dorms/recreation center to the main campus. A smaller, extended stay kind of hotel for UAS short-term students & short-term residents. Upgrading the existing buildings in the area and including low maintenance landscaping so the area is attractive and not one big concrete/asphalt blot on the land. Salmon streams will be preserved; large trees for eagle use will also be evaluated & kept in the scheme of things.






- More restaurants and related jobs

- development of the area should be limited to support of the harbor and associated activities.






