

### PROJECT DESCRIPTION

The City and Borough of Juneau has applied for the temporary use of a CBJ-owned parcel on Amalga Harbor Road as a staging area for construction materials during the resurfacing of Amalga Harbor Road and the replacement of bridges and guardrails along the road. The CBJ proposes to use about 2,500 square feet of a one acre parcel on the north side of Amalga Harbor Road for this purpose.

## **BACKGROUND**

In 2013 the Department of Transportation and Public Facilities (DOT&PF) submitted a project proposal to conduct preventative road surface maintenance on Amalga Harbor Road, and concurrently replace guardrails, signage, two bridges over tributaries of Peterson Creek, and the Peterson Creek Bridge. This project was listed as Need ID# 26889 in the 2013 – 2015 State Transportation Improvement Program (STIP), with budgeted design and construction in 2013. The Commission approved this project for consistency review on August 13th, 2013, with two advisory conditions:

1. Advisory Condition: CBJ 42.20.095(b) Construction of buildings and projects. It is unlawful to operate any pile driver, power shovel, pneumatic hammer, derrick, power hoist, or similar heavy construction equipment, before 7:00 a.m. or after 10:00 p.m., Monday through Friday, or before 9:00 a.m. or after 10:00 p.m., Saturday and Sunday, unless a permit shall first be obtained from the City and Borough building official. Such permit shall be issued by the building official only upon a determination that such operation during hours not otherwise permitted under this section is necessary and will not result in unreasonable disturbance to surrounding residents.
2. Advisory Condition: At least three business days prior to any traffic revision or road closure of any public street or portion thereof, the contractor shall provide written notification of the traffic revision plan to the CBJ Fire Marshall and Chief of Police. Failure to provide such notice may result in suspension of any CBJ-issued permits for such work, and is punishable by fine as an unlawful street closure under CBJ 72.17.010.

The contractor for the project, Trucano Construction, has applied for a Lands Use Permit to utilize approximately 2,500 square feet of CBJ owned land for eight months as a temporary staging area during the Amalga Harbor Road and bridges reconstruction project.

The temporary use of CBJ property for construction staging requires consistency review under CBJ 49.10.170(c).

CBJ 49.10.170(c) *City and borough land acquisitions, disposals and projects.* The commission shall review and make recommendations to the assembly on land acquisitions and disposals as prescribed by Title 53, or capital improvement project by any City and Borough agency. The report and recommendation of the commission shall be based upon the provisions of this title, the comprehensive plan, and the capital improvements program.

## **ANALYSIS**

The property in question is zoned as Rural Reserve. The use in the Table of Permissible Uses which most closely relates to the proposal is 22.100: *Temporary structures used in connection with construction*. This use is allowed with department approval in any zone.

The land to be used is currently vacant, and designated by the City as a lease site for the Herbert River Volunteer Fire Department. However, the fire department has indicated that they have no immediate plans for the site, and had no concerns with the land being temporarily utilized for construction staging.

The contractor intends to use an existing gravel pad on the site to place two Conex containers. In preparation for the site's use, alder trees and brush will be cleared from the pad. The contractor has indicated that they will return the site to its original condition at the end of the project.

In past reviews for the Amalga Harbor Road and bridges replacement project, Parks and Recreation Department Landscape Superintendent George Schaff had expressed concern that no invasive species be introduced to Amalga Harbor Meadows during fill and reseeding along the edges of the roadway. While the roadway construction project will likely involve the use of fill materials and reseeding, they will not be applied to the city-owned parcel in question.

## **CONFORMITY WITH ADOPTED PLANS**

### *Comprehensive Plan*

**POLICY 9.3. TO PRESERVE AS PUBLIC NATURAL AREAS THOSE PUBLICLY-OWNED LANDS AND SHORELINE AREAS THAT POSSESS IMPORTANT RECREATIONAL, SCENIC, FISH AND WILDLIFE, AND OTHER ENVIRONMENTAL QUALITIES OR ARE SUBJECT TO NATURAL HAZARDS.**

9.3 - SOP2 Acquire land or regulate its use as necessary to protect the public from natural hazards and to preserve sensitive natural resources.

Although Amalga Harbor Road provides access to several important recreational areas, including Earnest Gruening State Historical Park and Amalga Harbor, and is crossed by two anadromous fish bearing streams, these resources would not be disturbed by the proposed use of the parcel in question.

The project area is within the area identified in the CBJ Comprehensive Plan Guidelines and Considerations for Subarea 2:

*5. The Parks and Recreation Comprehensive Plan, Chapter 8, recommends a number of parks, trail, community garden and stream corridor improvements for this subarea. Those recommendations... include: ...  
(d) implement the Master Plan for Amalga Meadows area;*

Currently, there is no adopted master plan in place for the Amalga Harbor Meadows area.

### **HABITAT**

Staff foresees no habitat issues related to the proposed project. The area intended for construction staging is an existing graded pad, and staff determined that no wetlands would be impacted by this project. There are no documented eagle nests within 330 feet of the proposed staging area, and no anadromous fish bearing streams within 50 feet of the lot.

### **FINDINGS**

Staff finds this project consistent with Title 49 and plans adopted therein, with no conditions.

### **RECOMMENDATION**

Staff recommends that the proposed project, to utilize CBJ owned parcel USS 3662 Lot 3A for temporary staging of construction equipment, be found consistent with Title 49 and the plans adopted therein, and that the Planning Commission recommend that the Assembly **approve** the proposed project.

## **CITY/STATE PROJECT REVIEW REQUIREMENTS**

Each application for a City/State Project is reviewed by the Planning Commission at a public hearing. The permit procedure is intended to provide the Commission the flexibility necessary to make recommendations tailored to individual applications.

**Application:** An application for a City/State Project Review will not be accepted by the Community Development Department until it is determined to be complete. The items needed for a complete application are:

**Forms:** A completed City/State Project Review Application form and Development Permit Application form. The "land owner or lessee consent" signature is mandatory for all landowners on the Development Permit Application form.

**Fees:** No fee required for projects that cost less than \$2.5 million. For projects costing more than this amount, the fee is \$1,600.00. All fees are subject to change.

**Project Description:** A detailed letter or narrative describing the project.

**Plans:** All plans are to be drawn to scale and clearly show the items listed below:

- A. Plat, site plan, floor plan and elevation views of existing and proposed structures and land;
- B. Existing and proposed parking areas, including dimensions of the spaces, aisle width and driveway entrances;
- C. Proposed traffic circulation within the site including access/egress points and traffic control devices;
- D. Existing and proposed lighting (including cut sheets for each type of lighting);
- E. Existing and proposed vegetation with location, area, height and type of plantings; and,
- F. Existing physical features of the site (i.e. drainage, eagle trees, hazard areas, salmon streams, wetlands, etc.)

**Document Format:** All information that is submitted as part of an application shall be submitted in either of the following formats:

- A. Electronic copies may be submitted by CD, DVD or E-mail in the following formats: .doc, .txt, .xls, .bmp, .pdf, .jpg, .gif, .xlm, .rtf or other formats pre-approved by the Community Development Department.
- B. Paper copies may not be larger than 11" X 17" (Unless a larger paper size is preapproved by the Community Development Department).

**Application Review & Hearing Procedure:** Once the application is determined to be complete, the Community Development Department will initiate the review and scheduling of the application. This process includes:

**Review:** As part of the review process the Community Development Department will evaluate the application for consistency with all applicable City & Borough of Juneau codes and adopted plans. Depending on unique characteristics of the permit request the application may be required to be reviewed by other municipal boards and committees. Review comments may require the applicant to provide additional information, clarification, or submit modifications/alterations for the proposed project.

**Hearing:** All City/State Project Review Permit Applications must be reviewed by the Planning Commission. Once an application has been deemed complete and has been reviewed by all applicable parties the Community Development Department will schedule the requested permit for the next appropriate meeting. The Planning Commission will make a recommendation based on staff's analysis and forward it to the Assembly for final approval/denial.
