The Board of Adjustment, at its regular public meeting, adopted the analysis but did not adopt all findings listed in the attached memorandum dated October 16, 2014. The Commission made two new findings (as shown below) and approved the Variance to be conducted as described in the project description and project drawings submitted with the application with the following condition:

## New findings for Criteria 2:

The building next to the proposal will not be impacted because it is not a normal commercial business. The design of the proposed building will properly address rain water drainage and snow melt within the site.

## New findings for Criteria 6:

The improvements to the lot will increase property value, have a strong influence upon the nearby business containing Juneau Electronics, and developing the lot will lessen the collection of abandoned vehicles on the lot. Ample parking provided by the project will be a benefit to the neighborhood. The building and its design is a major benefit as the downtown grows. The building and the look and location will make for a more vibrant entrance to downtown.

• Prior to issuance of a Building permit, the applicant shall describe in a narrative and show on a site plan how snow and water run-off will be sufficiently managed on the site with the new encroachments allowed under this variance.

Any action by the applicant in reliance on the decision of the Board of Adjustment shall be at the risk that the decision may be reversed on appeal (CBJ §49.20.120).

Effective Date:

The permit is effective upon approval by the Board, October 28, 2014.

Expiration Date:

The permit will expire 18 months after the effective date, or April 28, 2016, if no Building Permit has been issued and substantial construction progress has not been made in accordance with the plans for which the development permit was authorized. Application for permit extension must be submitted thirty days prior to the expiration

date.
